### Children on the Move Main objectives and topics

**Existing knowledge** - To explore the research-base – identifying the best available, contemporary research on the health needs, prevention, early intervention and amelioration of refugee children and youth -To determine drivers and impact of violence on displaced children and youth.

**Clinical practice** - To raise awareness in child care professionals of physical, mental, behavioural and developmental health issues and needs of displaced children - To determine the role of paediatricians in the care of displaced children. -To identify tools for an efficient, equal and child rights based clinical practice

**Advocacy** -To disseminate displaced children health needs and inequalities to child care professions /sectors and children care stake holders

**Policies** -To develop inter-sectoral strategic responses to improve the current care for displaced children. -To propose policies aiming at improving the implementation of protection, promotion and participation rights of children
